### **When you come to our facility**

Please wear comfortable clothes when you come for your procedure. If you wear glasses or have a hearing aid, please bring these items with you. **With the exception of your co-pay and/or deductible, please leave all other valuables at home. Raleigh Endoscopy Center cannot be responsible for valuables.** You will need to bring your insurance card with you to ensure we have correct insurance filing information. **You will receive sedation for the procedure and MUST have an adult stay with you at the Center and drive you home.** Please contact your physician's office if you do not have someone to drive you home and they will reschedule your procedure.

You will be at our facility approximately two (2) to three (3) hours.

Due to the fact that we are an ambulatory surgery center, we do not honor Living Wills. However; as a service we can provide a copy of a Living Will, Healthcare Power of Attorney and a Medical Directive sheet that you can take home and complete at your leisure.

### **Following your visit**

You are not to drink alcoholic beverages, drive or operate machinery or make major decisions until the following day. The physician's office will follow up with you regarding any pathology obtained during your procedure.

***If you have an emergency following a procedure at our Center, please call your physician's office to reach the answering service. They will contact the physician on call.***
